TRIVIA

Trivia question from last month.

The US Army used the M60 medium machine gun for a number of years, 1957-1995. Often called the "pig" because it really was big, bulky, and generally a "pig" to have to hump through the woods (never mind the ammo belts, spare barrel, bipod or tripod, ugh...). The M60 was based on a weapon which got a great deal of use during World War II. What was the weapon, who used it, and what was one of the trademark signs that it was being used?



The MG42 was a German machine gun which had a trademark sound of ripping fabric because of its superior cyclic rate. Often called "Hitler's zipper" or "Hitler's buzzsaw," the MG42 was a very advanced design for the period, and would have an extended service life after World War II, as the 1970s photo of the Portugese paratrooper on the left shows. In addition, the design of the MG42 would be incorporated into the American M60 machine gun until the 1990s, when it was replaced by the M240, a Belgian-designed (Fabrique Nationale) machine gun based somewhat loosely on.... the MG42.

Next month's question: After American soldiers entered into combat during World War I, the war which brought us the flamethrower, poison gas, and aerial

bombing of populations, German diplomats lodged a protest with the American government due to use of a weapon which caused "excessive injury" to its targets, and that the Germans would execute any American caught with this weapon. What was the weapon?

"THE BIG HUNT" By Gary Danforth As told to me by Doug Willbrant

Preface: These monthly hunting stories are written by Gary Danforth as a means to keep the memory of his late brother, Richard "Dick" Danforth, alive. Dick loved the woods, hunting and planning hunts. He hunted for over 55 years using bow, rifle and muzzleloader. To keep these stories going and to keep the memory of my brother alive, I will need the help of others. I will need folks to furnish me with information and stories of their own to share. Thanks to my brother-in-law, Doug Willbrant, who hunted many years with my brother Dick, for helping me get the ball rolling with this initial story. I hope you enjoy the story and continued healthy hunting.

Story One: I spoke with Doug Willbrant at his home in North Petersburg. His family and himself own a large portion of woods and timber in that area, often called by us non owners in the family as Willbrant Mountain. Like most anyone whom I ever interviewed, and there have been many, having written for thirty years and published three books, the more I spoke with Doug, the more his memory came alive. First, he didn't think he could remember much, but as a few minutes went by, he found himself remembering more about Dick and his exploits. He shared several tidbits.

First, he recalled one hunt when he and Dick were on the mountain. "He used a 12 gauge shotgun with slugs this one day. He was sitting on a ledge under some pines when a spike horn came up through. I heard the shot. He hit the deer in the rib cage. What a mess that made. He said the deer got up and ran about five yards. There was a path of blood in the snow. That was about fifteen years ago."

Next, he shared a story about a hunt on the McCauliffe property between Eagle Bridge and Cambridge. Doug said that often Dick would hunt both the Willbrant Mountain and the McCauliffe property during any given hunting season. "If he didn't see much on the mountain he'd go up to McCauliffe's the next day to see what was up there. This one year he used a .45/70 to get a six pointer. I think Bill Grennen(a lifelong friend) got a six pointer the same day."

Then, Doug told me about the hunting camp which he and Dick and two others originally built in the early 1980's on Willbrant Mountain. The camp is located about eight tenths of a mile up the mountain. I can tell you from personal experience that the four wheeler ride up to the camp is steep; Very steep in some places. "Myself, Dick, Kurt Senecal and Mike Bornt built a 7 foot by 14 foot camp and hauled it up the mountain on a hay wagon. We (Willbrants ran the family farm since 1955). We couldn't get the camp up the mountain so we put another tractor behind the camp and pushed it up the mountain. Two years later we added on another 7 foot by 14 foot addition. It was crowded the first couple of years with four of us at the camp so we added on the addition. Then, Then, Dick got the idea 4-5 years later to add on another 16 foot by 24 foot section. We have a gas powered refrigerator and two wood stoves for heat. One wood stove keeps the camp plenty warm. At any one time ten to twelve people hunt at the camp.'
