Trivia question from last month. Almost a year ago to the day, a firearms legend passed away. He had several inventions to his credit. One of his most famous inventions was a rifle which he stated was "a weapon of defense," and "not a weapon for offense." Indeed, while accuracy is not the hallmark of his most famous rifle, reliability was.



"Na-Zdrovye!!!!"

Well, while alcohol and firearms don't mix, we can certainly begrudge a toast to the late Soviet Lieutenant-General Mikhail Timofeyevich Kalashnikov, inventor of the AKM, AK-74, PK Machine Gun, and most famously the AK-47, weapon of choice for insurgents around the world. He was conscripted into the Soviet Army in 1938. His mechanical skills saw him assigned as a tank mechanic and eventually tank commander. He was wounded in 1941 and was hospitalized for six months. He heard complaints from soldiers about the poor Russian infantry weapons and decided to build a new rifle for the Army. His talents did not go unnoticed and ended up assigned the Red Army's research and development division. Although some of his designs were rejected, in 1947, he hit paydirt with the AK-47. And the rest, as they say, is history.

Next month's question: The US Army used the M60 medium machine gun for a number of years, 1957-1995. Often called the "pig" because it really was big, bulky, and generally a "pig" to have to hump through the woods (never mind the ammo belts, spare barrel, bipod or tripod, ugh....). ## SUPPORT OUR EFFORT TO DEFEAT THE NY SAFE ACT ON JUDICIAL APPEAL Alex Hillis, Legislative Committee Chair

NRA and NYSR&PA have each spent about \$400,000 on legal action against the so-called New York SAFE Act to date. The SAFE Act is an obvious and direct assault on the Second Amendment rights of all New Yorkers. Like so many other private political deals in NY it was introduced and passed into law through back-door maneuvering of special interest groups against the expressed will of the people, without appropriate and reasonable public review.

With the re-election of Andrew Cuomo to a second term, and considering his unrealistic views regarding "gun control" pointing toward further unconstitutional "SAFE Act II" legislation (i.e. oppression of lawabiding gun owners coupled with a strange reluctance to adequately punish those using guns for criminal purposes), it is evident we need the suit to continue climbing the rungs of the appeals ladder until it can be taken up by an objective court.

The Owlkill Rod & Gun Club, registered member organization of both the NRA and NYSR&PA, is putting together a collective member donation to NYSR&PA in support of the current legal action against the SAFE Act. Every dollar collected from our membership up to and including our January club meeting will be consolidated by our treasurer, Randy Burgoyne, into one check to be sent to NYSR&PA headquarters in Albany. We presently have seed money of \$100 and hope to send out at least \$1000 to start the New Year off on an encouraging note for NYSR&PA president, Tom King. Please support this important effort!
